



# LOCAL ANAESTHESIA FOR DENTAL HYGIENISTS

Dental hygienists who are authorized and certified to administer local anesthesia (LA) in BC have the indication of "(C)" next to their license class. Successful completion of UBC's Local Anaesthesia for Dental Hygienists course meets the BC College of Oral Health Professionals criteria to obtain a "(C)" certification. **As a certification requirement, this is a NON-CREDIT Course.**

UBC CDE's Local Anaesthesia for Dental Hygienists program is a three and a half day course, designed to teach basic and current concepts of local anaesthesia, and administration of local anaesthetic agents. This course is comprised of two sessions. **Participants practice on each other, therefore you must consent to receive local anaesthesia and related treatments or you must provide a consenting stand-in for your partner.**

- Session I: September 28 and 29 (full days), consists of lectures, clinical instruction, and application of clinical techniques.
- Session II: October 18 (evening) and November 19 (full day), written and clinical evaluations.

**PRACTICUM:** During the interval between session I and session II participants must arrange to practice the techniques taught under personal supervision in a dental office. Further details regarding the practice period and supervision guidelines will be sent with your study guide.

If you are from out of province, it is your responsibility to make arrangements to complete your practicum in British Columbia or in a jurisdiction where dental hygienists may legally administer local anaesthetic agents. All participants must hold college required insurance.

## COURSE OBJECTIVES

Upon completion of this course, participants will be able to:

1. Describe head and neck anatomy related to the administration of local anaesthetic agents
2. Describe principles of pharmacology related to local anaesthetic agents and adrenergic drugs
3. Demonstrate the various techniques involved in the administration of local anaesthetic agents
4. Explain patient evaluation, complications and office emergencies as related to local anaesthesia

BC participants must be registered and in good standing with the BC College of Oral Health Professionals and must hold College required insurance. Out of province participants must hold a temporary (visitor) license from the BC College of Oral Health Professionals to attend this course and can apply at <https://oralhealthbc.ca/>

\*Should a participant be unsuccessful on the exam/s (Oct. 18/19) a supplemental exam/s will be held on November 2nd, 2024.
